1. Volunteer agrees to develop a supportive relationship within the Nordic Center framework and work cooperatively with the Nordic Center staff.
2. If volunteer is unable to provide agreed upon service as scheduled, due to illness or emergency, volunteer will make a reasonable or good faith effort to arrange for a substitute. Volunteer agrees to notify their Nordic Center Operations Manager in advance of absence.
3. If volunteer determines that he/she will be tardy for a scheduled service/program, he/she must notify Gold Run Nordic Center Supervisor prior to one hour of the scheduled start time for event.
4. Volunteer understands that there is no liability insurance, medical insurance coverage, or worker's compensation insurance for volunteer provided through the Nordic Center.
5. Volunteer understands that this Agreement pertains specifically to the above listed programs or type of service, and that any additional program arrangements must be pre-approved and coordinated with Nordic Center staff using a separate agreement.
6. Volunteer must follow rules and policies governing the Nordic Center.
7. Agreement may be terminated by the Nordic Center due to lack of participation in program, or if volunteer fails to follow rules and policies of the Frisco & Breckenridge Nordic Centers. Agreement may be terminated by volunteer only under extenuating circumstances and/or emergency situations. Any termination of Agreement must be negotiated through the Nordic Center Operations Manager.
8. Volunteer understands Nordic Season Pass Policy. Volunteer agrees to commit to specific dates and times agreed to on back of form and fulfill agreed upon commitment.
9. Volunteer understands he/she will be charged a pro-rated fee for his/her Nordic Season Pass if he/she does not fulfill agreed upon work commitments.

Volunteer agrees to indemnify and hold harmless the Frisco & Breckenridge Nordic Center's, its officers, employees, insurers, and self-insurance pool, from and against all liability, claims and demands on account of injury, loss, or damage, including without limitation claims arising from bodily injury, personal injury, sickness, disease, death, property loss or damage, or any other loss of any kind whatsoever, which arise out of or are in any manner connected with this Agreement, if such injury, loss, or damage is caused in whole or in part by, or is claimed to be caused in whole or in part by the negligence of volunteer, or any employee, representative, or agent of the volunteer, or which arises out of any workers' compensation claim of volunteer or any employee of the volunteer; except to the extent such liability, claim or demand arises through the negligence of Frisco & Breckenridge Nordic Center's, its officers, employees or agents. Volunteer agrees to investigate, handle, respond to, and provide defense for and defend against, any such liability, claims, or demands at the sole expense of the volunteer. Volunteer also agrees to bear all other costs and expenses related thereto, including court costs and attorney fees.
